We suggest that Guests with disabilities bring a companion who can provide any physical assistance that may be needed.

Our goal is to provide the best accommodations possible to all of our Guests. With the information that follows, and with the information our Team Members can provide in answering questions, we are confident the experience you have with us will exceed your expectations.

Attraction Information

Symbol Descriptions

Ride Warning Signs can be found at the entrance of each ride to help determine the attractions that are suitable for Guests based on their abilities. You will see the following symbols used throughout the Attraction Information Section and our Ride Warning Signs:



Metal detectors used at this attraction.



Remain standing on the moving walkway at all times.



Attraction is not allowed for Guests with a history of heart conditions or abnormal blood pressure.



Attraction is not allowed for Guests with back, neck, or similar physical conditions.



Expectant mothers are not allowed on this attraction.



Attraction is not recommended for Guests susceptible to motion sickness or dizziness.



Attraction is not recommended for Guests who are susceptible to fear of heights.



Attraction is not recommended for Guests who have medical sensitivity to strobe effects.



Attraction is not recommended for Guests who have medical sensitivity to fog effects.



Attraction is not recommended for Guests who have fear of enclosed spaces.



Attraction is not allowed for Guests wearing casts.



Attraction is not allowed for Guests with recent surgery or other conditions that may be aggravated by this ride.



Guests must be able to transfer to the ride vehicle seating with assistance from another member of their party. Attraction Attendants may not assist.



Guests must transfer to a standard wheelchair.



Guests may remain in their standard wheelchair throughout the attraction experience. PLEASE NOTE: this does not apply to Electric Convenience Vehicles (ECV) or motorized wheelchairs.



Guests may remain in their Electric Convenience Vehicle (ECV) or motorized wheelchairs throughout the attraction experience.



Guests must be of the indicated height to experience this attraction.



Guests must be within this range of height to experience this attraction. Guests outside this range may not ride.



Parental discretion is recommended due to mature themes, frightening images, and/or intense sound effects which may include pyrotechnics and gunfire.



Closed Captioning is available at this attraction. Ask an Attractions Attendant for details..



Closed Captioning/Assistive Listening Devices are available at this attraction. Ask an Attractions Attendant for details.



Open Captioning queue monitors available at this attraction. Ask an Attractions Attendant for details.



Please see an attendant for an assistive listening device.



Large print scripts with Braille are available for loan.



Attraction/ride vehicle can accommodate service animals.



Attraction/ride vehicle not accessible for service animals. Service animal kennel available upon request.



Guests **must secure** prosthetic limbs before riding to prevent hazards or loss due to ride forces.



Guests **must remove** prosthetic limbs before riding to prevent hazards or loss due to ride forces.



One natural leg must fit underneath the shin guard. Prosthetic limbs must be secured to prevent hazards or loss due to ride forces. Please see an attendant for assistance.

Rider Requirements

For most rides and attractions, you must be able to independently maintain an upright position, and brace and support your torso, neck, and head while absorbing sudden and dramatic movements throughout the experience. For additional requirements, please consult the ride and attraction listing in this guide. If you have any questions, please see an Attractions Attendant or contact Guest Services.

Accessibility Accommodations

At Universal Orlando we are proud of providing accommodations that create a welcoming, inclusive environment and accessible experiences for our Guests. The queue experience at the majority of our attractions is an integral part of telling the story of the overall attraction experience. As a result, we have constructed our queues to be accessible to Guests using wheelchairs (with the exception of Pteranodon Flyers at Universal Islands of Adventure).

INDIVIDUAL ACCESSIBILITY CARD PROGRAM

Universal Orlando has developed an Attractions Assistance Pass for Guests whose disability prevents them from waiting for extended periods in a conventional attraction queue environment. The Attractions Assistance Pass is an accommodation designed to provide equal access to theme park attractions and is not to bypass other Guests waiting in the attraction queue.

Guests requesting an attraction queue accommodation may obtain the IBCCES Individual Accessibility Card (IAC) by registering at accessibilitycard.org/ within 30 days of their visit to the park and at least 48 hours before their visit. The IAC registration consists of an online application that includes uploading necessary documentation. IBCCES does not require or ask Guests to disclose their medical or psychological diagnosis or condition.

Guests who only need to use their mobility device do not need to apply for the IAC as our attraction queues and park entrances are accessible. Once the Guest receives an approved IAC, a Universal Orlando Team Member will contact the cardholder to discuss the appropriate attraction queue accommodation for the cardholder's visit.

Note: An IAC does not guarantee a Guest will receive an Attractions Assistance Pass. Universal Orlando will determine the appropriate queue accommodation based on the cardholder's specific needs.

Note: Universal Orlando does not issue the IAC. Only IBCCES can issue the IAC.

Safety Advisory

FOR YOUR SAFETY

Shoes and shirts must be worn at all times. Read all health and safety requirements for each attraction as they are not all the same. You know your physical conditions and limitations; Universal Orlando does not. If you suspect your health could be at risk for any reason, or you could aggravate a pre-existing condition of any kind, do not experience the attraction.

RIDE INFORMATION

For your safety and the safety of others, always face forward, keeping your hands and feet inside the ride vehicle at all times. Remain seated until the ride comes to a complete stop and you receive instruction to exit the vehicle.

LOST ITEMS

Never attempt to recover a lost item while riding. Notify an Attractions Attendant for assistance and we will do everything we can to recover your property as quickly as possible.

RESTRAINT SYSTEMS

All passenger restraint systems, including lap bars, shoulder harnesses, and seat belts must be positioned and fastened properly to assure guest safety. Guests who do not fit properly within any safety restraint will not be permitted to ride.

MAGNETIC FIELDS

Many common devices produce electric or magnetic fields. They are used in everyday life as well as in our parks. The magnetic fields are generally confined to the equipment and should pose no concern as our Guests are not exposed to the proximity of the fields. Please see an Attractions Attendant for further information.

LOOSE AND FREE-FLOWING ARTICLES

Loose articles such as cell phones, photography devices, umbrellas, and keys are prohibited at most attractions and should be left with a non-rider or secured in a locker.

In addition, items that could potentially extend out of the ride vehicle, either before or during the ride experience, should be properly secured before riding. Excessively long hair, long and flowing articles of clothing, and/or accessories must be removed, tucked in, or tied back.

METAL DETECTORS



Guests wishing to experience Jurassic World VelociCoaster, The Incredible Hulk Coaster® and Hollywood Rip Ride Rockit will be required to pass through a metal detector as loose articles are strictly prohibited on these attractions.

General Information

PARKING

Guests entering the Toll Plaza with an Accessible Parking Permit will be directed to our accessible parking spots.

WHEELCHAIR RENTAL

If you require a wheelchair or Electric Convenience Vehicle (ECV), limited quantities are available for rent on a first come, first served basis. The Wheelchair Rental facilities are located at both theme park entrances. You will be asked to leave a monetary deposit in addition to the daily rental fee for the wheelchair. ECVs can only be rented just inside the main entrance turnstiles of each park at the stroller rental facility. If additional assistance is needed please notify a Team Member.

With the exception of the Hogwarts™ Express, none of the ride vehicles or attraction queues at Universal Orlando will accommodate ECVs. At those rides which can accommodate standard wheelchairs, Guests may transfer from their ECV into a standard wheelchair that is provided at each location. If you cannot transfer to a standard wheelchair, please see an Attractions Attendant.

RESTROOMS

All restrooms within both theme parks and CityWalk have facilities that are accessible for Guests using wheelchairs.

FAMILY RESTROOMS

For your convenience, Universal Orlando Resort provides family restrooms. Please refer to the mobile app for current locations.

FIRST AID

Our First Aid facilities are staffed with registered nurses and professional paramedics. In Universal Islands of Adventure, the primary First Aid Station is located in The Lost Continent. Please see mobile app for exact location. There is also a satellite facility located at Guest Services in the Port of Entry. At Universal Studios Florida, First Aid is located in New York next to Louie's Italian Restaurant. There is a satellite facility located in the front of the park next to Lost and Found. If you have any questions or need additional assistance, ask any Team Member or stop by Guest Services inside the main entrance.

NURSING FACILITIES

Nursing facilities are also located at our First Aid facilities.

Guests Using Wheelchairs

 For your enjoyment and convenience, all of our shopping and dining facilities are wheelchair accessible. Also, our stage shows and parade offerings have areas reserved for "Accessible Viewing." These areas are clearly marked with the International Symbol of Accessibility.

At most of our attractions, the queue experience is an important part of telling the story of the overall attraction experience. As a result, we have made all of our queues accessible to Guests using wheelchairs. There are specific boarding requirements and accommodations for those using wheelchairs at each attraction. In all cases, if you are capable of transferring to the attraction seating (either by yourself or with the assistance of another person in your party) you may transfer.

For the safety of our Guests, certain attractions contain a height requirement due to the dynamic elements in the ride system. Guests who are unable to stand independently for height verification should see an Attractions Attendant for further information.

Guests Using Electric Convenience Vehicles (ECV)

 Universal Orlando's resort shuttles are equipped with a wheelchair lift to transport Guests to/from our Resort hotels, CityWalk and Volcano Bay. Wheelchairs, ECV's, and other mobility devices must fit without being forced on lifts, ramps, and in designated wheelchair spaces. Guests in ECV's and other mobility devices must transfer to the shuttle seating.

At the attractions, with the exception of Hogwarts™ Express, none of the ride vehicles or attraction queues at Universal Orlando will accommodate Electric Convenience Vehicles (ECV). At those rides which can accommodate standard wheelchairs, Guests may transfer from their ECV into a standard wheelchair that is provided at each location. If you cannot transfer to a standard wheelchair please see an Attractions Attendant.

Guests must adhere to Universal's safe usage policy noted below for powered mobility devices such as, but not limited to, power-driven wheelchairs, electric convenience vehicles/scooters, Segways, or other power-driven mobility devices.

- Guests using powered mobility devices must operate them at a safe speed equivalent to or slightly slower than surrounding pedestrians.
- Powered mobility devices are prohibited on escalators and must utilize elevators.
- Guests using powered mobility devices must power down and remove keys (as applicable) when left unattended.
- Guests using powered mobility devices are responsible for any harm, damages, or injury caused to any person or property caused by the powered mobility device user's intentional, reckless, or negligent usage of the powered mobility device.

- We are not responsible for any harm or damage caused to any powered mobility device by other Park Guests, or while a powered mobility device is left unattended, or while a powered mobility device is used in violation of these rules.
- Hoverboards are not permitted in the park.

WHITE CANES



Many attractions can accommodate a Guest with a white cane which may need to be collapsed and secured during the ride experience. On those attractions where the white cane may become lost due to ride forces or present a potential hazard to other Guests, an Attractions Attendant will hold the white cane for you once you are seated. The Attractions Attendant will have the white cane available as soon as the attraction vehicle is stopped in the unload area. Service Animals



Trained Service Animals are welcome at Universal Orlando Resort. Animals who do not meet the definition of a Service Animal will not be permitted in the park. Service Animals must be harnessed, leashed or tethered, unless these devices interfere with the Service Animal's work or the individual's disability prevents using these devices. In that case, the individual must maintain control of the animal through voice, signal, or other effective controls. In order to assist the owner in making an informed decision about their Service Animal's safety, each attraction has its own specific entry/boarding requirements. ATTRACTION TUBES AND RAFTS

Certain attractions use different types of tubes and rafts that some Guests may find uncomfortable. Guests with certain body dimensions may not be accommodated on some of our attractions. Maximum weight limits are posted at the entrance of the attraction and in this guide under the Attraction Information section.

MAGNETIC FIELDS

Many common devices produce electric or magnetic fields. They are used in everyday life as well as in our parks. The magnetic fields are generally confined to the equipment and should pose no concern as our Guests are not exposed to the proximity of the fields. Please visit Guest Services or Concierge in the park for further information.

LOOSE AND FREE-FLOWING ARTICLES

All articles must be free of any sharp adornments that could damage the slides. Please leave any loose articles with a non-rider or in a locker. Guests with excessively long hair or long and flowing articles of clothing or accessories are required to take certain precautions before experiencing any attraction.

RF TECHNOLOGY

Universal Orlando Resort utilizes systems and devices that include active radio frequency (RF) technology. The levels of RF energy they generate are comparable to those found in common consumer devices. These systems and devices are designed, tested, and manufactured to comply with Federal Communications Commission (FCC) regulations. If you use an electronic medical device and have concerns regarding RF interference, please consult your medical device manufacturer or a qualified medical professional.

LOCKERS

Lockers are available at the front of the park, Wave Village, River Village, and Rainforest Village (additional fees may apply).

PARKING

Guests entering the garage with an Accessible Parking Permit will be directed to the parking area for Guests with disabilities. Transportation via bus is provided for all Guests to access Volcano Bay. If you need assistance in boarding the bus, please see an Attendant.

WHEELCHAIR RENTAL

If you require a wheelchair, limited quantities are available for rental on a first come, first served basis. The wheelchair rental facility is located on the third floor of the Parking and Transportation Center. You will be asked to leave a monetary deposit, plus the daily rental fee for the wheelchair. While in the park, if additional assistance is needed, please notify a Concierge attendant.

RESTROOMS

All restrooms within Volcano Bay have facilities that are accessible for Guests using wheelchairs.

FAMILY RESTROOMS

For your convenience, family restrooms are located at the front of the park and in the Rainforest Village and River Village areas of the park.

FIRST AID

Our First Aid facility is staffed with registered nurses and professional paramedics. At Volcano Bay, the primary First Aid Station is located next to the park entrance. If you have any questions or need additional assistance, ask any Team Member.

FAMILY SERVICES

At Volcano Bay you'll find nursing facilities and a family restroom area located in the First Aid Station by the park entrance.

Guests Using Standard Wheelchairs or Motorized Wheelchairs



For your enjoyment and convenience, all of our shopping and dining facilities are wheelchair accessible. These areas are clearly marked with the International Symbol of Accessibility. For each individual attraction, there are specific boarding requirements and accommodations for Guests traveling in either a standard wheelchair or a motorized wheelchair. Most attractions require Guests using wheelchairs to transfer from their mobility device to ascend or descend steps of a tower. In addition, Guests will need to be able to independently position themselves in the proper riding position and exit the pool.

Within the park, various water sprays are used throughout the general pathways. Care should be given to any personal wheelchair and mobility accessories as the pathways will be wet.

The following Attractions are accessible to Guests who are able to fully transfer from a wheelchair to the attraction either on their own or with assistance of another person in their party. See specific ride requirements to assess ability to ride, and for additional information regarding accessible entrance locations in the Attraction Information section.

Guests Using Electric Convenience Vehicles (ECV)



We apologize, but none of the attraction queues at Universal Volcano Bay will accommodate Electric Convenience Vehicles (ECV). At attractions that can accommodate standard wheelchairs, Guests may transfer from their ECV into a standard wheelchair which is provided at select locations. The attractions that have standard wheelchairs for transfer are Maku Puihi Round Raft Rides and the Krakatau Aqua Coaster. If you cannot transfer to a standard wheelchair, please see an Attendant.

Guests must adhere to Universal safe usage policy noted below for powered mobility devices such as, but not limited to, power-driven wheelchairs, electric convenience vehicles/scooters, Segways, or other power-driven mobility devices.

- Guests using powered mobility devices must operate them at a safe speed equivalent to or slightly slower than surrounding pedestrians.
- Powered mobility devices are prohibited on escalators and must use the designated pathway upon arriving at Universal Volcano Bay entry area.
- Guests using powered mobility devices must power down and remove keys (as applicable) when left unattended.
- Guests using powered mobility devices are responsible for any harm, damages, or injury caused to any person or property caused by the powered mobility device user's intentional, reckless, or negligent usage of the powered mobility device.
- The Park is not responsible for any harm or damage caused to any powered mobility device by other park Guests or while a powered mobility device is left unattended or while a powered mobility device is used in violation of these rules.
- Hoverboards are not permitted in the park.

Guests Using Oxygen Tanks/Devices

Oxygen tanks are only allowed in dry areas of Universal Volcano Bay. Dry areas include merchandise and food locations, cabanas, common walkways, and beach areas.

Guests with Vision Disabilities

This Guide for Rider Safety and Accessibility is available in large font and embossed in Braille at Guest Services, located at the front of the park.

Virtual Line™ reservation paddles employ the use of audio jacks for audible instructions on receiving a return time throughout the park. For Guest safety, we ask that you provide your own device to utilize this feature.

Many attractions can accommodate a Guest with a white cane. The cane may need to be collapsed on some attractions and all white canes must be free of any sharp adornments that may damage the slides.

Service Animals



Trained Service Animals are welcome at Universal Orlando Resort. Animals who do not meet the definition of a Service Animal will not be permitted in the park. Service Animals must be harnessed, leashed, or tethered, unless these devices interfere with the Service Animal's work or the individual's disability prevents using these devices. In that case, the individual must maintain control of the animal through voice, signal, or other effective controls.

Service Animals are welcome in all of our restaurant and merchandise locations. Please be aware that Service Animals are not permitted in any pool or attraction.

Portable Service Animal kennels are available while you're on each attraction. Please note that our Team Members cannot assist in the handling of Service Animals.

Guests with Limb Differences

Evacuations

If an evacuation of an attraction or venue is required, Guests may need to navigate stairs, narrow walkways, or ladders. Please have a member of your party assist you or inform an Attendant if you require further assistance.

Accompanied by a Supervising Companion

Any child who meets the minimum height requirement of the attraction but does not meet the 48" (122cm) ride-alone height requirement must be accompanied by a Supervising Companion. A Supervising Companion is defined as someone who is 14 years of age or older and meets all other attraction ridership requirements. At all of our attractions, children under 48" (122cm) must be able to sit upright unassisted on all rides. See individual attraction descriptions below for details on Supervising Companion options exclusive to each slide, river, and pool.

Descriptions and Restrictions

There are a few general conditions which apply to all attractions: All of the attractions at Universal Volcano Bay incorporate safety systems designed to accommodate people of average physical stature and body proportion. Therefore, certain restrictions may apply for some Guests at each attraction based on the nature and dynamics of the experience. This includes restrictions based on body shape or size, height, weight, medical conditions, or other physical conditions which could be aggravated by the experience. Our prime consideration is the ability of each person to endure the dynamics of each attraction without risk of injury to that person or others.

Explanation of Terms

We use a standard set of terms to describe each of our attractions. Our intent is to provide you with a clear understanding of each attraction's dynamics and physical requirements so that you can make an informed decision about experiencing them. The attraction information in this guide will be presented in the following categories:

Attraction Description

This section outlines the specific ride vehicle movements to be expected while riding.

Important Access Information

This section outlines specific physical restrictions and requirements to ensure a comfortable and safe ride experience.

Rider Requirements

This section outlines the physical abilities required to experience the attraction.

Information for Guests Using Wheelchairs

This section outlines the level of accommodation and other special instructions for those persons using wheelchairs as they experience the attraction. It is important to review this information fully before experiencing an attraction and consult with an Attendant to clarify issues or questions that you may have. As part of the **IMPORTANT ACCESS INFORMATION**, there are some fundamental requirements necessary to ride which may differ slightly from attraction to attraction.

Kala of Kala and Tai Nui Serpentine Body Slides

ATTRACTION DESCRIPTION

This attraction features a high-speed free-fall slide that begins in an enclosed capsule with a trap door, while riders twist through a tube into a splashdown lane 125-feet (28-meters) below.

IMPORTANT ACCESS INFORMATION



This attraction may not accommodate certain people due to their body shape or size.

RIDER REQUIREMENTS

One natural arm that terminates below the elbow and two natural legs that terminate below the knee are required. Stand with back, head, and heels against the wall of the capsule, with legs crossed below the knee and arm(s) crossed over the chest and maintain this position throughout the ride. Must also be able to absorb the sudden and dramatic movements including sudden accelerations, dramatic tilting, and jarring actions.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are ambulatory to ascend stairways and exit the landing pool without assistance are able to ride.

Ohyah and Ohno Drop Slides

ATTRACTION DESCRIPTION

This attraction features physically challenging body slides with sudden twists and turns. Ohyah finishes with a 4-foot (1.2-meter) drop and Ohno finishes with a 6-foot (1.8-meter) drop into a pool 10-feet (3-meters) in depth. Strong swimming ability required.

IMPORTANT ACCESS INFORMATION



RIDER REQUIREMENTS

Two natural arms that terminate below the elbow and two natural legs that terminate below the knee are required. Lie feet first, face up, with legs crossed below the knee and arms crossed over the chest and maintain this position throughout the ride. Must also be able to absorb the sudden and dramatic movements including sudden accelerations, dramatic tilting, and jarring actions. NOTE: All riders must have strong swimming ability. This attraction exits into a 10-foot (3-meter) pool.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are ambulatory to ascend stairways, cross swinging bridges, and exit the landing pool without assistance are able to ride.

Puka Uli Lagoon

ATTRACTION DESCRIPTION

This attraction is a pool with a depth of 0–4 feet (0–1.2 meters). Guests may relax and swim around the pool at their leisure.

IMPORTANT ACCESS INFORMATION



Children under 48" (122cm) must wear a U.S. Coast Guard-approved life vest. Non-swimmers should wear a U.S. Coast Guard-approved life vest. Diaper age children must wear swim diapers covered by their swimsuit.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are able to fully transfer from a wheelchair onto the pool lift may access the attraction. Please see an attendant for assistance.

Maku of Maku Puihi Round Raft Rides

ATTRACTION DESCRIPTION

This attraction is a dynamic slide with steep drops and sudden twists, turns, and spinning while riding in a five-person raft.

IMPORTANT ACCESS INFORMATION



This attraction may not accommodate certain people due to their body shape or size.

RIDER REQUIREMENTS

Either (a) one functioning hand (natural or prosthetic) with two legs (natural or prosthetic) which terminate below the knee or (b) two functioning hands (one may be a functioning prosthetic) are required. Continuously hold the handles during the entire ride experience. Sit upright with legs (natural or prosthetic) towards the middle of the raft and maintain an upright position throughout the entire ride. Must also be able to absorb the sudden and dramatic movements including sudden accelerations, dramatic tilting, and jarring actions. No lap-sitting.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are able to fully transfer from a wheelchair into the raft may utilize the lift located to the right of the main queue entrance. Please see an Attendant for assistance.

Puihi of Maku Puihi Round Raft Rides

ATTRACTION DESCRIPTION

This attraction is a dynamic slide with steep drops where you will experience zero-gravity hang time, sudden twists, turns, and spinning while riding in a five-person raft.

IMPORTANT ACCESS INFORMATION



This attraction may not accommodate certain people due to their body shape or size.

RIDER REQUIREMENTS

Two functioning hands (one may be a functioning prosthetic) are required. Continuously hold the handles during the entire ride experience. Sit upright with legs (natural or prosthetic) towards the middle of the raft and maintain an upright position throughout the entire ride. Must also be able to absorb the sudden and dramatic movements including sudden accelerations, dramatic tilting, and jarring actions. No lap-sitting.

INFORMATION FOR GUESTS USING WHEELCHAIRS


Guests who are able to fully transfer from a wheelchair into the raft may utilize the lift located to the right of the main queue entrance. Please see an Attendant for assistance.

TeAwa The Fearless River

ATTRACTION DESCRIPTION

This attraction is a fast moving experience with sudden churning rapids, choppy waves and depths up to 6-feet (1.8-meters).

IMPORTANT ACCESS INFORMATION



Children under 48" (122cm) must enter the river accompanied by a Supervising Companion. For your safety, all participants must enter and exit at the designated locations only.

RIDER REQUIREMENTS

All riders must independently support themselves throughout the entire attraction experience. Children under 48" (122cm) must enter the river accompanied by a Supervising Companion. All guests must wear a U.S. Coast Guard-approved life vest.

INFORMATION FOR GUESTS USING WHEELCHAIRS


Guests who are able to fully transfer from a wheelchair into the river may access the attraction either through the sloped entry or the pool lift provided. Please see an Attendant for the accessible entrance location.

Taniwha Tubes - Tonga & Raki

ATTRACTION DESCRIPTION

This attraction features four dynamic, twisting water slides featuring steep drops, sudden twists and turns, and water sprays while riding in a tube.

IMPORTANT ACCESS INFORMATION



This attraction may not accommodate certain people due to their body shape or size.

RIDER REQUIREMENTS

Either (a) one functioning hand (natural or prosthetic) with two legs (natural or prosthetic) which terminate below the knee or (b) two functioning hands (one may be a functioning prosthetic) are required. Continuously hold the handles during the entire ride experience. Sit upright with legs (natural or prosthetic) towards the front of the tube and maintain an upright position throughout the entire ride. Must also be able to absorb the sudden and dramatic movements including sudden accelerations, dramatic tilting, and jarring actions. No lap-sitting.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are ambulatory to ascend stairways, cross swinging bridges, and exit the landing pool without assistance are able to ride.

Punga Racers

ATTRACTION DESCRIPTION

This attraction features four individual high-speed slides where riders slide through dark areas with sudden drops and turns.

IMPORTANT ACCESS INFORMATION



This attraction may not accommodate certain people due to their body shape or size.

RIDER REQUIREMENTS

Two natural legs that terminate below the knee are required. You should be able to independently: (1) Lie back with your head and torso against the slide surface with legs crossed below the knee and (2) support your torso, neck, and head while absorbing sudden and dramatic movements including sudden accelerations, dramatic tilting, and jarring actions within the slide and through the end of the run-out lane.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are ambulatory to ascend stairways and exit the run-out without assistance are able to ride.

Krakatau Aqua Coaster

ATTRACTION DESCRIPTION

This attraction takes you on a thrilling, high-speed water coaster ride within a four-person boat that includes powerful climbs, plunging drops, and side-to-side motion.

IMPORTANT ACCESS INFORMATION



This attraction may not accommodate certain people due to their body shape or size.

RIDER REQUIREMENTS

Either (a) one functioning hand (natural or prosthetic) with two legs (natural or prosthetic) which terminate below the knee or (b) two natural functioning hands are required. Continuously hold the handles during the entire ride experience. Independently maintain yourself in an upright position while seated. Must also be able to absorb the sudden and dramatic movements including sudden accelerations, dramatic tilting, and jarring actions. No lap-sitting.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are able to fully transfer from a wheelchair into the boat may utilize the elevator located to the left of the main queue entrance. Please see an Attendant for assistance.

Runamukka Reef

ATTRACTION DESCRIPTION

Runamukka Reef is a play area for children with slides, bubbling geysers, water guns, and dump cups.

IMPORTANT ACCESS INFORMATION



Maximum rider height for slides is 54" (137cm).

RIDER REQUIREMENTS

Two natural arms that terminate below the elbow and two natural legs that terminate below the knee are required. Sit upright or lie back face up with feet first and with legs crossed below the knee and arms crossed over the chest throughout the entire ride. Infants must be able to independently support their head and neck. No lap-sitting. Diaper age children must wear swim diapers covered by their swimsuit.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are ambulatory to ascend stairways with or without assistance are able to ride.

Tot Tiki Reef

ATTRACTION DESCRIPTION

Tot Tiki Reef is a play area for children with slides, bubbling geysers, water guns, and dump cups.

IMPORTANT ACCESS INFORMATION



Maximum rider height for slides is 48" (122cm).

RIDER REQUIREMENTS

Two natural arms that terminate below the elbow and two natural legs that terminate below the knee are required. Sit upright or lie back face up with feet first and with legs crossed below the knee and arms crossed over the chest throughout the entire ride. Infants must be able to independently support their head and neck. No lap-sitting. Diaper age children must wear swim diapers covered by their swimsuit.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are ambulatory to ascend stairways with or without assistance are able to ride.

Kopiko Wai Winding River

ATTRACTION DESCRIPTION

This attraction is a gently moving 3-feet (1-meter) deep river through shaded areas, caves, and waterfalls.

IMPORTANT ACCESS INFORMATION



Children under 48" (122cm) must wear a U.S. Coast Guard-approved life vest and be accompanied by a Supervising Companion. Non-swimmers should wear a U.S. Coast Guard-approved life vest. For your safety, all participants must enter and exit at the designated locations only.

RIDER REQUIREMENTS

Be able to independently support yourself throughout the experience. Diaper age children must wear swim diapers covered by their swimsuit.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are able to fully transfer from a wheelchair into the river may access the attraction through the sloped entry provided. Please see an Attendant for the accessible entrance location.

Honu of Honu ika Moana

Attraction Description

This attraction is a dynamic slide with steep drops where you will experience zero-gravity hang time, sudden twists, turns, and spinning while riding in a five-person raft.

IMPORTANT ACCESS INFORMATION



This attraction may not accommodate certain people due to their body shape or size.

RIDER REQUIREMENTS

Two functioning hands (one may be a functioning prosthetic) are required. Continuously hold the handles during the entire ride experience. Sit upright with legs (natural or prosthetic) towards the middle of the raft and maintain an upright position throughout the entire ride. Must also be able to absorb the sudden and dramatic movements including sudden accelerations, dramatic tilting, and jarring actions. No lap-sitting.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are ambulatory to ascend stairways and exit the landing pool without assistance are able to ride.

ika Moana of Honu ika Moana

ATTRACTION DESCRIPTION

This attraction is a dynamic slide with steep drops, sudden twists, turns, and spinning while riding in a five-person raft.

This attraction may not accommodate certain people due to their body shape or size.

RIDER REQUIREMENTS

One natural arm that terminates below the elbow and two natural legs that terminate below the knee are required. Stand with back, head, and heels against the wall of the capsule, with legs crossed below the knee and arm(s) crossed over the chest and maintain this position throughout the ride. Must also be able to absorb the sudden and dramatic movements including sudden accelerations, dramatic tilting, and jarring actions.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are ambulatory to ascend stairways and exit the landing pool without assistance are able to ride.

The Reef

ATTRACTION DESCRIPTION

This attraction is a pool with a depth up to 6-feet (1.8-meters). Guests may relax and swim around the pool at their leisure.

IMPORTANT ACCESS INFORMATION



Children under 48" (122cm) must wear a U.S. Coast Guard-approved life vest. Non-swimmers should wear a U.S. Coast Guard-approved life vest. Diaper age children must wear swim diapers covered by their swimsuit.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are able to fully transfer from a wheelchair onto the pool lift may access the attraction. Please see an Attendant for assistance.

Waturi Beach

ATTRACTION DESCRIPTION

This attraction is a wave pool with depths up to 6-feet (1.8-meters). Waves can be sudden and dynamic.

IMPORTANT ACCESS INFORMATION



Children under 48" (122cm) must wear a U.S. Coast Guard-approved life vest. Non-swimmers should wear a U.S. Coast Guard-approved life vest. Guests may enter the pool from the shore only.

REQUIREMENTS

Be able to independently support yourself during sudden onset of waves and currents. Diaper age children must wear swim diapers covered by their swimsuit.

INFORMATION FOR GUESTS USING WHEELCHAIRS

Guests who are able to fully transfer from a wheelchair into the pool may access the attraction through the sloped entry provided. Please see an Attendant for the accessible entrance location.
